**Sir Jonathan Faull KCMG:**

Sir Jonathan Faull was born in Chatham, Kent in 1954. He is Chair of European Public Affairs at the Brunswick Group.

He previously spent 38 years at the European Commission where he worked for many years in the Directorate General of Competition, from the starting grade to Deputy Director General. From 1989 to 1992 he worked in the cabinet (private office) of the competition Commissioner (Leon Brittan).

He was the Commission's Spokesman and Director General of Press and Communication (1999-2003), Director General of Justice and Home Affairs (2003-2010), Director General of Internal Market and Services (2010-2015) and Director General of the Task Force on the British referendum on membership of the EU (2015-2016).

He is the author of many articles on European law and policy; co-editor of a leading work on European Competition Law; Visiting Professor, King's College London and College of Europe, Bruges; Emeritus Professor, Vrije Universiteit Brussel; Member of the Advisory Boards of the Centre for European Reform and the Institut Jacques Delors – Notre Europe.

He was knighted in the Queen's Birthday Honours in June 2017.

**Mr. Michael Rühle:**

Michael Rühle, born 1959 in Stuttgart, Germany, is currently Head, Energy Security Section, in the Emerging Security Challenges Division in NATO's International Staff. Previously he was Head, Speechwriting, and Senior Political Advisor in the NATO Secretary General's Policy Planning Unit. Before joining NATO's International Staff in 1991, Mr. Rühle has been a Volkswagen-Fellow at the Konrad-Adenauer-Stiftung, Sankt Augustin, Germany, and a Visiting Fellow at the Center for Strategic and International Studies (CSIS), Washington, D.C. He holds an M.A. degree in Political Science from the University of Bonn. Mr. Rühle has published widely on international security issues in, among others, American Foreign Policy Interests, Comparative Strategy, European Security, Frankfurter Allgemeine Zeitung, Russia in Global Affairs, International Affairs (Chatham House), International Herald Tribune, The Journal of Transatlantic Studies, NATO Review, Parameters, Strategic Review, and The World Today. He has also co-authored a book on missile defence. His essay "Good and Bad Nuclear Weapons" was published in March 2009 in both German and English.

## **Colonel Frank Düwel:**

Colonel Frank Düwel is an armoured officer by heart and a highly distinguished staff officer with a huge amount of experience in operational planning, force planning and force generation, both nationally and internationally. Additionally, he is a successful military leader with substantial experience as commander on company as well as on battalion level .

Shortly after Colonel Düwel had successfully finished the German General Staff Course, he started to build up an initial international profile. He worked as G3 operations on corps level and then attended the Canadian Forces College in Toronto. In the German Ministry of Defence, covering the military strategic level, he initially worked as an assistant branch chief and later on as executive assistant to Deputy Chief of Staff. He reported directly to the Deputy Chief of Staff and embodied the principal source of advice related to all matters covering long term concepts and doctrine development as well as force planning and force generation .

In addition, Colonel Düwel held two command appointments. He commanded an ArmD Coy and later on he assumed command of 183, ArmD Battalion. Following he was then selected as Directing Staff at the German Staff College, followed by an operational tour as Military Assistant to DCOM KFOR. Consequently, Colonel Düwel was selected for promotion and appointed as ACOS G3 in a major military district command.

In July 2010 he took over as the Branch Head of SHAPE FORCE GENERATION Team, responsible of generating with his great team all capabilities needed for all NATO Operations and NRF, working directly for DSACEUR, General Sir John McColl and General Sir Richard Shirreff.

In Jan 2010 he became ACOS G3 HQ ARRC where upon his experience within NATO he was appointed the CREVAL OPR to prepare the HQ for the evaluation as the NRF 2017 LCC and consequently, even not a British officers, became the Team Leader for the evaluation of UK HQ 20 Amd Bde as the VJTF (L) HQ for NRF 2017.

Due to his affiliation with multinationality he applied for his current appointment, back to SHAPE, as the Deputy Director CCOMC. Leaving his daughter behind in UK to study, and his son (unfortunately) joining the German Airforce instead of the Army he is presently living near Mons, Belgium with his wife Jutta.
