#### The subject of the paper:

Modern Jihadism: The Case of Singapore and Europe Muslims.

#### **Background:**

The rise of the Islamic State (IS) has presented a new form of warfare, touted as the modern jihadism. Their extreme ideology, sophisticated organization and operational methods have created a profound impact on the psyche of societies and the response frameworks of states worldwide. The ideological and terrorist threats affecting European and Western countries are viewed with deep concerns, as seen from the issues of radicalization and deadly terrorist attacks in these regions in recent years. Concomitantly, the influence of extremism and modern terrorism, as espoused by the IS, has intensified from the epicenter of the Middle East towards Asia and South East Asia. Singapore, being in the midst of this turmoil in South East Asia, faces the same daunting challenges as the others. Lately, IS-claimed terrorist attacks in Indonesia and Malaysia, as well as the discovery of terror plots against Singapore, meant that the occurrence of an attack in Singapore is not a matter of "if", but "when".

Be it in Europe or Singapore, countries are grappling with the phenomenon of modern jihadism, such as understanding its impact on societies, how it impinges national security and ultimately what the responses should be. The inextricable link of modern jihadism to the radical interpretations of Islamic teachings and perpetration of terrorism typically by individuals self-identified as Muslims, has put the Muslims in any country that is affected by the phenomenon "in the limelight" for two reasons. First, the Muslim community is most vulnerable to the influences of extremist ideology and they are potential perpetrators or supporters of terrorist acts. Secondly, this group will be subjected to a certain perception from the rest of the society, who cannot but feel apprehensive about the presence of Muslims in their environments. The social status and image of the Muslims will be profoundly affected depending on the counter-extremism and counter-terrorism efforts of the state, as well as the reactions of the society in general.

#### Goal of the paper:

1. To examine the influence of modern jihadism on the Muslim population of a state, in relations to its national security and social compact.

2. To analyze and understand the similarities and differences of this influence between Singapore and Europe due to the different cultural, geographical and political environments.

#### **Research questions:**

How is the national security and social compact of a country affected by the influence of modern jihadism on its Muslim population? What can be learned from the comparative study between Singapore's and Europe's strategies to counter extremism and terrorism?

#### **Research claims (if any):**

1. South East Asia is an ideal hub for ideological extremism and is a vast resource potential for modern terrorism to breed. A proper handling of the Muslim situation in Singapore is a must for Singapore's stability and security.

2. As the phenomenon of modern terrorism and extremism will only exacerbate in the near future, Singapore has to continuously learn and adapt its strategies.

#### Method of presenting the idea of the research (Outline):

This paper will focus only on the Muslim population, and not the other ethnic groups of a society, not that the latter is not susceptible to the influences of extremism or terrorism but rather the close relations between jihadism and Islam/Muslims described in the background section is worthwhile for further investigation.
