SUBJECT: INVITATION TO EXERCISE DYNAMIC MOVE 2020-I. CALLING LETTER FOR THE COMBINED PLANNING CONFERENCE

1. **General.** COM MARCOM as OSE for the exercise DYNAMIC MOVE 2020-I (DYME 20-I) is pleased to invite the Commands, Nations and Partners to participate in this event which will take place in the Belgian-Netherlands Naval Mine Warfare School (EGUERMIN) in Oostende, Belgium, from 27 January to 06 February 2020.

2. The type and form of the exercise. Exercise DYNAMIC MOVE is an biannual, tactical level (CTG/CTU) Command Post Exercise (CPX) and Computer Assisted Exercise (CAX) focussed on Naval Mine Counter Measure (NMCM) training. In 2020 the exercise will be conducted in two separate places. The first one (DYME 20-I) in EGUERMIN, with the training priority of SNMCMG1 Staff, and the second one (DYME 20-II) in MARICODRAG (MARICENDRAG) with the training priority of SNMCMG2 Staff.

3. **Aim of the exercise.** The aim is to exercise Naval Mine Warfare (NMW) tactics and procedures, the Allied Worldwide Navigational System (AWNIS) and the Naval Cooperation and Guidance for Shipping (NCAGS) procedures in order to enhance participants' ability to conduct littoral and amphibious operations during NON ART 5 CRO.

4. **Partner's participation.** IAW MTEP instructions and reference C., the exercise DYME 20-I is open to Partners and Non-NATO Entities (NNEs). This includes all planning conferences and the exercise execution phase. NNEs participation will be coordinated through SHAPE MPD as the responsible agency. Only Operational Partners can be considered as Primary Training Audiences (PTAs), for all other participants the Observers Formula will be utilised.

5. **Exercise Design.** The exercise will be supported by EGUERMIN's Naval Mine Warfare Gaming System (NMWGS). The NMWGS will visualize the effects of the CTGs/CTUs decisions by taking into account mine threat, performance of the NMCM systems in use and the level of effort provided by MCM units.

6. **Combined Planning Conference.** For DYME 20-I there will be only one Combined Planning Conference (IPC/MPC/FCC). Representatives from Commands, Nations and Partners who are planning to participate in the exercise (in any of the execution phases) are invited to attend the conference that will be held at EGUERMIN on **22 - 23 October 2019.**

7. **Conference participants.** During two days of conference all issues related to preparation and execution of DYME 20-I will be discussed. Those include exercise documentation (scenario, OPGEN, NCAGS, AWNIS, NMWGS, exercise schedule, etc.) and manning for all the levels (CTF, CTG, CTU). Therefore, delegated participants should preferably be MCM specialists with prior exercise planning experience, staffing knowledge and authority to bid for available posts.

To run the exercise in proper way and transfer as much knowledge as possible to the Training Audience (TA) the right manning of CTF level is crucial. All nations intrested in taking a lead in CTGs and CTUs cubicles are requested to provide support to CTF cels with CTF leaders, experienced MCM SMEs or NMWGS controllers.

Conference participants are expected to have the minimum equivalent rank of Lieutenant/Lieutenant Commander (OF-2/OF-3). As the conference will be held in English, a good command of the English language is also necessary.

8. **Security clearances.** The security classification of the conference will be NATO UNCLASSIFIED; however, personnel attending the meeting must have at least a NATO CONFIDENTIAL security clearance in order to access the EGUERMIN's facilities. For NATO Partners that will attend the session the base access will be granted. NNEs accessibility will be coordinated with SHAPE MPD as the responsible agency for NNEs IAW the MTEP.

9. **NATO subsidy policy.** Please be aware that the standard NATO Partnership subsidy policy applies to this activity and related events.

Foreword

- 1. The Combined Planning Conference (IPC/MPC/FCC) for the Exercise Dynamic Move 2020-I (DYME 20-I) will be held in Oostende, BELGIUM from 0900L 22 to 1700L 23 October 2019.

Financial assistance

6. Standard NATO/Partners subsidy policy applies to this event, approved by NATO under reference number **ACO.4272.1**; therefore delegates from Partner Nations who are entitled to financial support may be supported financially, upon official Partner's request. The NATO Action Authority in this event – MARCOM – may provide the following level of financial support:

- Up to 100% of incurred costs for Partner Countries whose GNI per capita at PPP is below USD 10'000;
- Up to 80% of incurred costs for Partner Countries whose GNI per capita at PPP is between USD 10'000 and 13'550; exception that increase the level of financial support up to 100% may be decided by DCOS MPD on a case-by-case basis.

7. The financial assistance is to be formally requested through and approved; the Financial Assistance Request Form (FARF in Appendix 1) duly stamped and signed has to be early forwarded to HQ MARCOM, NLT **20 September 2019**; a single national MOD approved bank account (IBAN) is necessary to start the financial support procedure. Application submitted after the deadline (10 days before the event) may not be considered. Up to two participants per financially eligible Partner Nation can be subsidized and reimbursed. In accordance with the reference, travel, accommodation, meals, conference

and VISAs fees can be subsidized and reimbursed; the approval letter of subsidization will be sent by MARCOM through the PNMR in SHAPE MPD before the event.

8. For eligible Partners Countries and if formally and timely requested, the reimbursement system after the event will be applied.

Reimbursement

9. MARCOM will reimburse eligible Partners' participating in the event. In order to do so, Partners are required to submit to MARCOM a Financial Reimbursement Request Form (FRRF) in Appendix 2), together with original receipts, within 30 days after the completion of the event. Reimbursement may include:

- Travel: reimbursable itinerary will start from initial point of embarkation for outbound flights – Internal transportation to the initial point of embarkation for outbound flights is a national responsibility and so is to be considered entirely nationally founded. Where the normal form of travel is air, the standard cost shall be based on the economy class. No pre-paid flight tickets will be booked and provided by MARCOM before the event.
- Accommodation: actual costs for lodging only. No reimbursement will be possible for any "incidental charges" (telephone calls, pay-TV, room mini-bar, laundry, etc.).
- Meals: actual costs for meals (breakfast, lunch and dinner if not included within the conference) can be subsidized if the cost doesn't exceed the current daily rate of subsistence allowance rate standard for NATO members.

3. OVERALL REQUIREMENTS

a. General framework

(1) Exercise DYNAMIC MOVE (DYME) is an biannual Naval Mine Counter Measure (MCM) Command Post (CPX) Computer Assisted Exercise (CAX) designed to train participants from NATO and national commands, including Operational Partner nations, in a range of naval operations mainly focused on the NRF concept.

(2) This exercise supports the preparation of Standing NATO MCM Group command staffs for NRF certification and forms part of a work-up period for the Standing MCM Groups as well. It also enables the exchange of experience and information between incoming and incumbent command

staffs as well as other participants, representing NATO and Partners nations' MCM units.

(3) The intention for the exercise is to build international TG/TU command staff capabilities to conduct significant MCM operation with a full range of MCM assets.

b. Relationship to the other exercises

There is no direct relationship with other exercises.

4. EXERCISE AIM AND OBJECTIVES

a. Aim

DYME 20-I is a MARCOM-sponsored CAX/CPX conducted to:

(1) Exercise NMW tactics and procedures;

(2) Prepare command staffs of Standing NATO MCM Groups for NRF certification;

(3) Exercise the coordination of AWNIS, NCAGS, Water Space Management (WSM), and other aspects of warfare.

b. Exercise objectives

(1) To prepare the command staffs of SNMCMGs for the NRF certification in accordance with the NRF concept.

(2) To prepare the national NMW (MCM) Command Staffs assigned to take part of SNMCMGs (or other operational MCMTG).

(3) To exercise NATO Naval Mine Countermeasures (NMCM) operations in the context of littoral operations.

(4) To exercise NMCM procedures and tactics.

(5) To exercise the interpretation of NMW data to affect command decisions.

(6) To exercise interoperability between NATO members and Operational Partners.

(7) To provide a platform for evaluation of new doctrines and experimental tactics (EXTACs) if required.

5. GEO-STRATEGIC SITUATION

a. The scenario will be decided during combined conference. If the scenario is going to be SCOLKAN 1 than the geo-strategic situation is as below.

b. The exercise scenario is based on the SKOLKAN 1 and will use the realworld geography of the Baltic Sea region. Some hydrographical data will be modified in order to support the exercise and training objectives. The scenario is entirely fictitious and without any political implications.

c. At the centre of the crisis is the LIVONIAN Oil Field . In the 1990s, the scientific community speculated that large Oil and gas reserves were located in the Gulf Of Finland; since then, Bothnia (fictitious country located in the southwestern part of the real Finland) has announced the will to start a large Offshore Oil

Exploration program. When evidences of a large oil and gas reserves were found, Bothnia began taking an aggressive posture towards Estonia. Bothnia, in order to enlarge their claim over the LIVONIA OIL FIELD, which is mainly located in ESTONIAN TTW and EEZ, started to put pressure on Estonia over the EEZ disagreements, announcing the re-examination of the dormant territorial claims on Hiiumaa and Saaremaa. Since then Bothnia has conducted minor and major incursions into ESTONIA TTW and airspace with ships and aircraft. In the last months of 2018 the situation deteriorated further, and concerns over the threat of large-scale military action by Bothnia led Estonia and Baltic states to call for Art. 4 consultations. On this basis, the NAC tasked SACEUR to assess potential options, which led to the decision to deploy the NRF to Estonia as a pre-emptive measure in January 2019.

6. CONCEPT OF THE EXERCISE

a. Settings

(1) Exercise DYME 20-I will simulate a non article 5 Crisis Response Operation (CRO) which will involve the maritime NRF.

(2) A full-scale Q-routes system will be activated IOT facilitate advance force MCM operations preparing the battle space for own forces and follow-on shipping.

(3) The AOO will be scaled to the number of participating CTG/CTUs.

(4) Within the CJTF organisation, Naval MCM forces will be represented by multinational TGs/TUs staffs. The number of active MCM TG's and MCM TU's will depend on the number of participating HQs/Units; each of whom will conduct a similar exercise programme.

Number of CTF response cells (Game Teams max. three in DYME20-I) with senior debriefers and a support cell representing areas of expertise that are in scope of the exercise interest. CTF will control the exercise through the use of directives and injects (Main Events List/Main Incident List – MEL/MIL). Dynamic scripting is to be expected.

(5) Agreed Naval Mine Warfare Gaming Software (NMWGS) settings will be developed and set up by the EGUERMIN.

(6) The Minelaying Plan will be developed by NMW COE, based on the MARCOM and the EGUERMIN settings. (Has to be agreed by NMW CoE and confirmed two weeks prior to the exercise execution).

(7) MARCOM will work towards organising media training / SIMPRESS for the participants in both conduct stages.

b. Phases of DYME 20-I conduct stage

DYME 20-I will be executed in phases as follows:

(1) Phase I – Planning. On the basis of the OPGEN received, MCM CTGs will plan and issue their operational directives. MCM CTGs will coordinate planning with subordinate CTUs. The CTU staffs will organise their TU Command Posts (cubicles) and prepare initial taskings for the MCMVs and other NMCM assets under their command. At the beginning of this phase a

RELEASABLE TO PFP, MD, ICI, PATG staggered academic programme will be provided with lectures, briefings and training relevant to and focusing on the exercise.

(2) Phase II – CAX session. Participants will execute NMW (MCM) operations in support of non-article 5 CRO iaw exercise documentation and issued/received directives. Coordination with NCAGS and AWNIS will be managed between CTF and MCM CTGs. Issues related to the other warfare areas of expertise will be managed by MEL/MIL injects as directed by CTF and information provided by NMWGS.

(3) The Exercise DYME 20-I Hot Wash-Up is planned for 06 FEB 2020 after CAX is compleated. Participants are expected to prepare briefings (and feedback) iaw requirements outlined in the exercise documentation.

(4) During the exercise the CTF leaders will provide a daily debrief on the participants' performance. The Game Teams will be composed of NMW SMEs with SNMCMG experience (ex COMs, PSOs) or similar, and the Game Controlers.

7. TRAINING AUDIENCE PARTICIPATION REQUIREMENTS AND RESPONSIBILITIES

- a. Training Audience (TA)
 - (1) NMW (MCM) CTG and CTU staffs are the Training Audience.

(2) NATO nations' NMW (MCM) command staffs planned for SNMCMGs deployment (incoming and standby SNMCMGs Command Staffs).

(3) Non-NRF NATO and Operational Partners' staff personnel to man NMW (MCM) TG/TUs cells.

b. Miscellaneous

(1) As the working language will be English, an intermediate knowledge of the language (STANAG 6001, lev. 2-2-2-2 at minimum) is required.

(2) DYME 20-I participants are required to have a Security Clearance Certificate up to and including NATO CONFIDENTIAL or equivalent for Partners nations' representatives.

(3) This exercise has a limited number of places available. During the combined conference the bids for participation will be confirmed. The following priorities in descending order will be taken into consideration in the manning process:

- (a) SNMCMGs staffs (standby)
- (b) SNMCMGs staffs (incoming).
- (c) NRF assets staff (rotation 2020/21).
- (d) Projected NRF assets staff (future rotations).
- (e) CJSOR assets staff.
- (f) NATO pool of forces assets staff.
- (g) NATO members not included above.
- (h) Operational Partners.

8. EVALUATION REQUIREMENTS

There is no formal evaluation activities planned for inclusion in DYME20-I.

9. ANALYSIS REQUIREMENTS

There are no formal analysis activities planned for inclusion in DYME20-I. However, this should not limit the opportunities to utilize analysis in order to benefit ongoing capability/concept development activities.

10. EXTERNAL SUPPORT

Manning. The exact manning requirement will be identified by the combined conference and will be promulgated by signal message. Properly qualified personnel will be requested from NATO commands (NCS) and nations (NFS) to provide SME's as stated in para. 6 a. and b.

- a. External contribution supporting the conduct of the exercise
 - (1) Allied Maritime Command staffs personnel to augment the CTF staff.

(2) BE/NL Naval Mine Warfare School EGUERMIN to provide NMWGS, and respective personnel.

(3) NMW COE to support the Minelaying Plan development and to support CTF manning.

(4) Participating nations are requested to provide SMEs to support CTF manning. Detailed organization and manning requirements will be developed during the planning process.

(5) Nations are requested to support the CTF manning with former COM's and PSO's of SNMCMG's or senior NMW SMEs having similar experience.

(6) Nations are invited to augment the EGUERMIN NMWGS staff with controllers.

b. SIMPRESS Training

MARCOM will work towards organising media training / SIMPRESS for the participants.

11. PARTNER PARTICIPATION

DYME 20-I is open for Partners Nations to participate. Partners will be invited to attend planning conferences in order to discuss their possible participation. Constraints and limitations regarding their participation should be discussed at the earliest stage.

(1) Only Operational Partners can be considered as Primary Training Audiences (PTAs) for all other participants the Observer Formula will be utilized.

(2) Practical management of partner participation in the exercise events (Visa support letters, subsidization and e-PRIME reports) will be dealt by Bi-SC MPD with cooperation of MARCOM N9.

12. POLITICAL IMPLICATIONS

No international political implications are foreseen.

14. PUBLIC AFFAIRS POLICY

The real-world PA policy for the exercise will be active. PA policy to be coordinated between HQ MARCOM, EGUERMIN in due time.

15. VISITORS AND OBSERVERS

Visitors and Observers are invited to participate in the execution phase of the exercise. If a Visitors and Observers request is received during the exercise

planning process, the programme requirements will be coordinated through both OCE and HN points of contacts (POCs).

16. ADMINISTRATION, LOGISTICS, REAL LIFE SUPPORT AND FUNDING

- a. Budget
 - (1) Budget planned for DYME 20-I is 57 400 € (EURO).

(2) The final cost for the exercise will be negotiated between Allied Maritime Command (HQ MARCOM) the BE/NL Mine Warfare School EGUERMIN, NMW COE. Standard NATO/PfP funding rules apply, including common exercise cost sharing by sending nations.

b. Funding Requirements

(1) NATO common funding provided by ACO will be granted only in accordance with NATO Financial Regulations and within the limits foreseen within the Exercise and Training budget, in order to cover the minimum operational requirements.

(2) Should the provided funding prove to be insufficient, the viability of the exercise will be re-evaluated. A detailed cost estimate, along with an impact statement must be forwarded to HQ MARCOM N7 EX Fund Manager as soon as the shortfall has been identified.

(3) Costs will be identified, tracked and controlled through normal NATO accounting and fund management procedures.

c. Host Nation Support (HNS)

HQ MARCOM as the OCE for this exercise, will coordinate any HNS requirements with the EGUERMIN (HNs).

d. Force protection

Protection of personnel participating in the planning and the conduct of the exercise is the HN responsibility. It will be executed in close cooperation with the OCE. The BE/NL Mine Warfare School EGUERMIN and NMW COE are requested to provide appropriate security support and to discuss changes in security situation with the OCE as soon as possible. If the situation demands so, the EGUERMIN and NMW COE are requested to discuss with OCE potential preventive counter measures prior to their implementation.

On completion of the exercise, the following reports must be prepared and submitted accordingly:

a. First Impression Report (FIR)

CTGs and CTUs must complete their FIRs and submit them to the OPR prior the exercise HWU.

18. LESSONS IDENTIFIED / LESSONS LEARNED

a. Lessons Identified (LI) and preliminary recommendations must be drawn from every possible sources related to the exercise. All LI will subsequently be staffed to become Lessons Learned (LL).

b. LL that meet established validity criteria will be forwarded to the NSA/NMWWG and JALLC to be included and published in the Lessons Learned Data Base.

19. OTHER SPECIAL INSTRUCTIONS

a. The EGUERMIN and NMW COE will provide facilities to support the lecture sessions, syndicate work and the CAX phase. Further support, when needed will be determined in details during the forthcoming planning process.

b. No medical facilities are available on EGUERMIN. If required, EGUERMIN and NMW COE personnel will liaise with the local medical facilities.

c. Security designation and release of classified documentation:

(1) NATO agreed policy and procedures will be applied as directed in ACO Security Directive AD 70-1.
