MEMORANDUM FOR JOINT LESSONS LEARNED CONFERENCE 2018 (JLLC 18) PARTICIPANTS

Subject: Joint Lessons Learned Conference 2018 (JLLC 18) Announcement Memorandum #2

1. <u>General</u>. JLLC 18 will be held in the Executive Conference Center (ECC) located at the Joint Staff Hampton Roads Complex, Suffolk, Virginia, 25-27 September 2018. Travel days are 24 and 28 September 2018. This memorandum provides the theme and conference overview, draft agenda, key dates and suspenses; as well as additional planning and preparation considerations for participation in the JLLC 18.

2. <u>Overview</u>. The theme of JLLC 18 is, "Lessons Learned from Global Integration". The purpose is to improve the understanding of challenges and successes experienced during integration of global operations, and to inform Joint Staff planning and execution of the Chairman, Joint Chiefs of Staff Global Integrated Exercise (GIE) series. Speakers and panelists have been contacted to confirm participation and have been provided information to assist with development of their presentations. In addition to these presentations, we are asking each organizations that did not previously submit a "Smart Sheet" should prepare one for JLLC 18. Submissions will be consolidated into the 2018 "JLLP Smart Book". This book provides a roster of the Joint Lessons Learned Community of Practice, and will be annually updated and distributed during the JLLC. "Smart Sheet" submissions are due 28 August.



Governing Instructions: The Director, Joint Staff J-7 (DJ-7), serves as the executive agent for the Chairman's Joint Lessons Learned Program (JLLP). The DJ-7 ensures overall integration of the program as a vital ingredient of joint force development, advancing operational effectiveness of the current and future Joint Force. Execution of the JLLP mission is carried out by two divisions within the J-7 Deputy Directorate for Future Joint Force Development (FJFD): the Joint Lessons Learned Division (JLLD) and the Joint and Coalition Operational Analysis (JCOA) Division. JLLD manages all programmatics and policies associated with the JLLP, to include the maintenance of governing instructions, provision of the Joint Issue Resolution Process related to joint operational and strategic lessons. JCOA provides the JLLP with its deployable analytical capacity. The Chairman's JLLP is governed by CJCSI 3150.25 and its accompanying CJCSM 3150.25.

Collection Expertise:

Operational Analysis: JLLD provides rapidly deployable, tailored teams of multi-disciplined analysts to support joint, combined, and interagency missions worldwide. In addition, JCOA reachesback to its larger body of analysts who remain in support from Suffolk.

Operational Support Team: The Operational Support Team (OST) is JLLD's direct, real-time link to the Joint Staff, combatant commands, component planners, and the interagency. The OST injects lessons into ongoing planning and analysis and collaborates with partners to solve complex operational issues.

Joint LL Conference (JLLC)

- Collaborative venue where the Joint Staff (JS), Services, combatant commands (CCMDs), Combat Support Agencies (CSAs), and other LL organizations present issues, share ideas, and discuss/identify program and process improvements to enhance collaboration/issue resolution

Joint LL Program Review (JLLPR)
