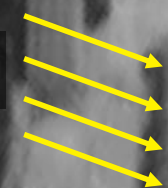

Elements suspected as S-300 launchers arrived to Hmeimim airfield during the last days of September 2018. Based on iSi imagery, the elements were temporarily deployed at the airfield, until the end of the construction of its storage area and permanent deployment site near Masyaf. The elements were probably transferred to their current location on the third week of October 2018.



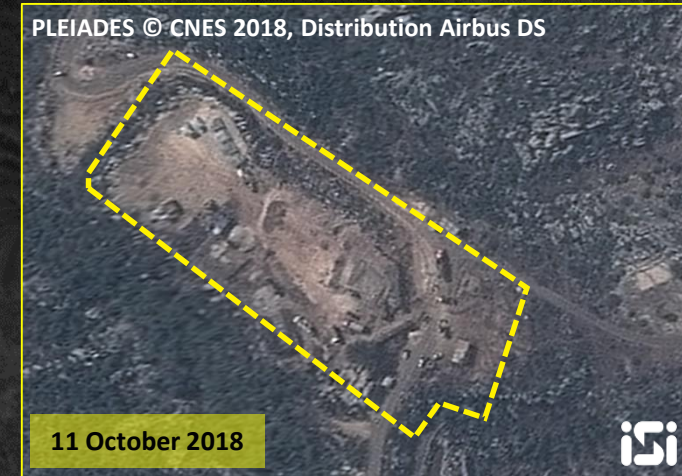
